Clinical skills taught at the University of Gloucestershire

Students will receive theory and practice sessions based on best practice from Clinical skills.net and the Royal Marsden Manual of Clinical Procedures

It is the student's responsibility to ensure the organisation they have a placement with allows them to undertake this skill All skills performed by students either need to be under direct supervision or are signed as competent by their practice assessor

Some skills will be signed by the University as having been complete through simulation and those are highlighted in your skills passport

The Nursing Field Skills guide should be used to guide students and practice supervisors/Assessors

The aim of the guideline is not to restrict the practice development of our students and their educational experience but to help protect both student and Practice assessor/Supervisor accountability by providing a greater level of clarity to the clinical expectations.

The skills are presented in TWO sections – Proficiencies and Medicine Management and have been divided into four categories that provide detail on whether or not a student can undertake the skill and are numbered and colour coded as follows:

1	YES, Direct supervision NOT required once assessed as competent by a Practice Assessor/Supervisor
2	YES, but always under DIRECT SUPERVISION by a Practice Assessor/Supervisor
3	YES, but ONLY following completion of relevant TRUST TRAINING AND REQUIRED COMPETENCIES – Documentation must be seen and verified by a Practice Assessor/Supervisor - skills may not be transferable between healthcare providers
4	NO, NOT in any circumstance

DIRECT SUPERVISION:

For the purpose of this document Direct Supervision means:

In the immediate presence and under the constant observation of a Registered Nurse who is suitably qualified to undertake the skill themselves and is able to assess student ability and performance.

The lists are <u>not designed to restrict the autonomy or practice of Practice supervisors/Supervisors and</u> DOES NOT give students an automatic right to undertake a skill because it appears in a certain category. **The Practice assessor/supervisor retains accountability for assessing an individual student's knowledge, attitude and competence.**

Relevant **NMC Standards** and **Local Trust Policy should be read before** any skill / procedure is undertaken.
